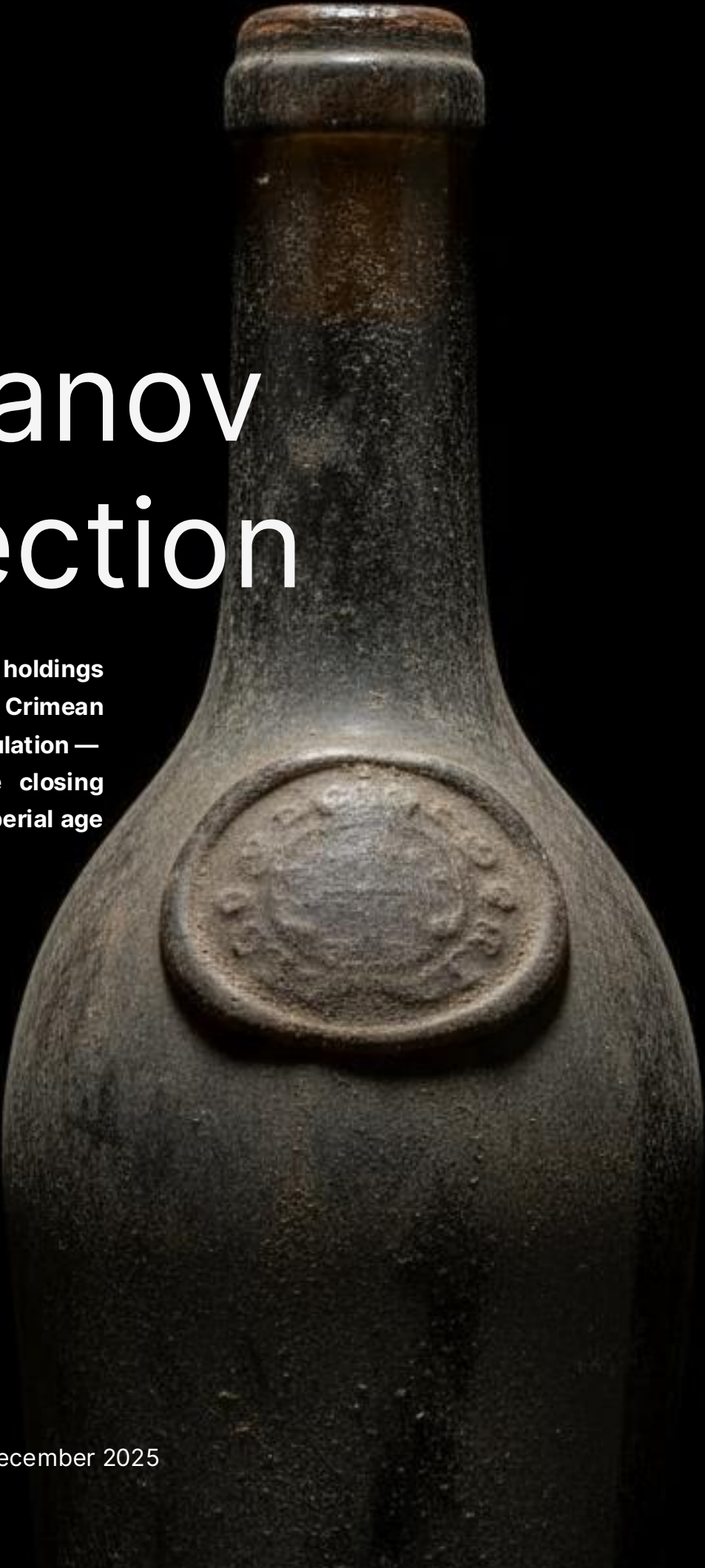

01 Romanov Legacy

Testament to Romanov Timeless Splendor

Wines offered in this auction originate from the historic **Imperial cellars at Livadia in Crimea**, established in the 1890s under the patronage of Tsar Nicholas II and the direction of **Prince Lev Golitsyn**, founder of the Massandra winery. The Livadia cellars were created to supply the **Romanov court** with a dedicated collection of fine & dessert wines, stored in ideal conditions within the mountain tunnels overlooking the Black Sea.

Many of the surviving bottles from this collection bear the imperial seals, testifying to their association with the royal household.

Heritage Enshrined, Encapsulated in Every Bottle

While historical records confirm that Livadia and its associated estates frequently exchanged gifts of their wines with **European royal households**, including Britain's, these bottles are best described as **examples from the Imperial Romanov cellars at Livadia**, preserved in bond and released under the auspices of the Massandra winery.

Wines from these cellars have been exhibited internationally and offered at major Western auctions including Sotheby's and Bonhams, where their exceptional provenance and condition have been widely recognised.

Together, the 36 lots offered here represent one of the **finest private holdings** of **pre-Revolutionary Crimean wines** remaining in circulation — a tangible link to the closing chapter of Europe's **imperial age of viniculture**.



Massandra Winery: Foundations of Romanov Wine Heritage

Established in the 1890s under Tsar Nicholas II's patronage and guided by Prince Lev Sergeyevich Golitsyn, Massandra Winery was purpose-built to supply the Romanov summer palaces at Livadia. Between 1894 and 1897, a fan-shaped tunnel cellar was carved into the Crimean foothills, maintaining a constant 10 – 12 °C and offering capacity for approximately 2.5 million litres of cask wine and one million bottles in dedicated ageing galleries.

Drawing upon French and Italian expertise, the estate planted premier European grape varieties alongside native vines. By the turn of the century, wine production had grown more than six-fold, centralizing the South Coast's finest Muscats, Tokay-style dessert wines, Kagor sweet reds, and Port-style blends under one roof.

Massandra's vintages earned international distinction at the 1896 Nizhny Novgorod Industrial Exhibition and again in Paris in 1900, where Prince Golitsyn received the Grand Prix for sparkling wine. Subsequent medals at Hamburg, Magdeburg, and Tiflis solidified Massandra's reputation for excellence.

From Imperial Tables to Enduring Legacy

Massandra wines graced primarily the imperial tables at Livadia and across the Romanov estates. Exports were limited, making **original pre-Revolution vintages among the rarest treasures** to surface at Sotheby's, Bonhams, and other leading auction houses.

Nationalized in 1922 yet protected thereafter as a state collection, Massandra's cellars endured through upheaval and war. Today, a handful of these imperial vintages—each reflecting a precise moment in Crimean terroir—remain intact. For the discerning collector, they represent not merely aged wine, but a **living link to Romanov refinement**, forever preserved in stone-cold vaults beneath Livadia.

A Bridge Between Thrones: HMS Marlborough & the Escape of the Romanovs

In the dying embers of Imperial Russia, as the Bolshevik Revolution swept across the vast empire in 1917, the glittering world of the Romanovs vanished almost overnight. Once serenaded by orchestras and surrounded by opulence in their palaces along the Black Sea, the surviving members of the royal family now faced mortal danger. Amidst this chaos, in the spring of 1919, a British warship slipped quietly into the Bay of Yalta — on a mission as gallant as it was secret.

That ship was **HMS Marlborough**, dispatched by King George V to rescue his embattled cousins, the Dowager Empress Maria Feodorovna and other members of the Romanov dynasty. Anchoring just off the coast near the summer retreat of Livadia Palace — a stone's throw from the famed Massandra Winery, whose cellars had once supplied the tsars' tables — the Marlborough came not as a vessel of war, but as a vessel of mercy.

The rescue was a race against time. Bolshevik forces were advancing rapidly, and the collapse of order was nearly complete. In the eerie calm before their arrival, the royal party — elderly, bewildered, and clinging to their last vestiges of dignity — was ferried HMS Marlborough, autographed by many of the Imperial passengers through the night across the wine-scented hills and orchards of Crimea to the British ship.

HMS Marlborough steamed away from Yalta under cover of darkness, she carried with her the last great exodus of Imperial Russia's royal bloodline — a dynasty's fading legacy cradled in the arms of the Royal Navy. Behind them, the great palaces of the Romanovs stood empty, and the priceless wines of Massandra, locked in their cool stone vaults, became silent witnesses to a vanished world.

Today, over a century later, a rare handful of those very wines — bottled before the fall of the dynasty, laid down in Massandra's legendary cellars while the Romanovs still reigned — have emerged from history. Each bottle bears not just the noble terroir of Crimea, but the echo of an empire's end and the quiet courage of a ship that came to save a family, silent witness to history, bottled for posterity.

This UK-based private collection offered here was acquired directly from the Massandra winery and imported to the United Kingdom in 2006, where it has been held continuously in bonded storage at Octavian under optimal conditions. These rare pre-Revolutionary wines from the Imperial Romanov cellars represent one of the finest private holdings of Crimean viniculture remaining in circulation.

Selected bottles have been authenticated through presentation at Sotheby's and Bonhams, as well as Reeman Dansie, providing discerning collectors with an exceptional opportunity to acquire wines of imperial provenance and historic significance.



Signature Styles Before 1917 & Comparison with European Wines

Tokay Ai-Danil

Modeled on Hungarian Tokaji but produced by fortification rather than aszú maceration. Flavors overlapped (honey, apricot, citrus) but style diverged.

Muscat (Livadia)

Comparable to French vin doux naturel (Rivesaltes, Frontignan).
Aromatic, fortified, long-lived.

Kagor

Inspired by Portuguese Port, with emphasis on sweetness and spice. Less tannic than authentic Douro Ports. A favorite in the Romanov court.

Aging practices

Like Madeira and Sherry houses, Masandra relied on oxidative cask aging and long bottle maturation in cool tunnels, ensuring longevity.

Tasting Notes



The Massandra Collection comprises exceptional fortified and dessert wines of remarkable complexity and longevity.

Over three decades, from the seminal Sotheby's tastings of 1990-1991 through subsequent assessments by Bonhams (2006), independent specialists (2013), and the comprehensive Baghera Wine masterclass (2016), professional tasters have **consistently documented that these wines age with extraordinary grace and refinement**. This broad consensus provides compelling evidence of the collection's exceptional pedigree.

Fortified dessert wines from this collection typically carry elevated alcohol levels of 15-18% ABV—a defining characteristic that contributes significantly to their remarkable stability and extended aging capacity.

The wines display **complex flavor profiles of dried fruits, warm spices, honey, caramel, and concentrated stone fruit character**. These qualities deepen further over time, and the wines continue to evolve positively even now, decades after their original production.

Origin & Import to the UK

This exceptional collection originates from the renowned Massandra wine estate in Ukraine and was imported to the United Kingdom in 2006 for market presentation. The wines were imported directly from the winery and placed into bonded storage at Octavian, where they have been maintained ever since under optimal conditions of temperature and humidity.

Auction History & Market Exposure

Selected bottles from this collection were presented at major London auction houses, including Sotheby's (December 2004) and Bonhams (2006), ensuring comprehensive market exposure and authentication by leading international fine wine specialists. These prestigious auction house viewings provide additional provenance verification and have established the collection's quality and authenticity within the fine wine market.

Continuity of Custody

The wines have been held continuously in bonded storage at Octavian since their arrival in the UK. The collection has remained under professional warehouse management for nearly two decades, with full documentation of rotation numbers and storage records maintained throughout this period.

Packaging

The lot presented includes wines in their original protective presentation. Individual bottles are housed in traditional wooden cases or specialized protective packaging suited to secure storage and transportation. 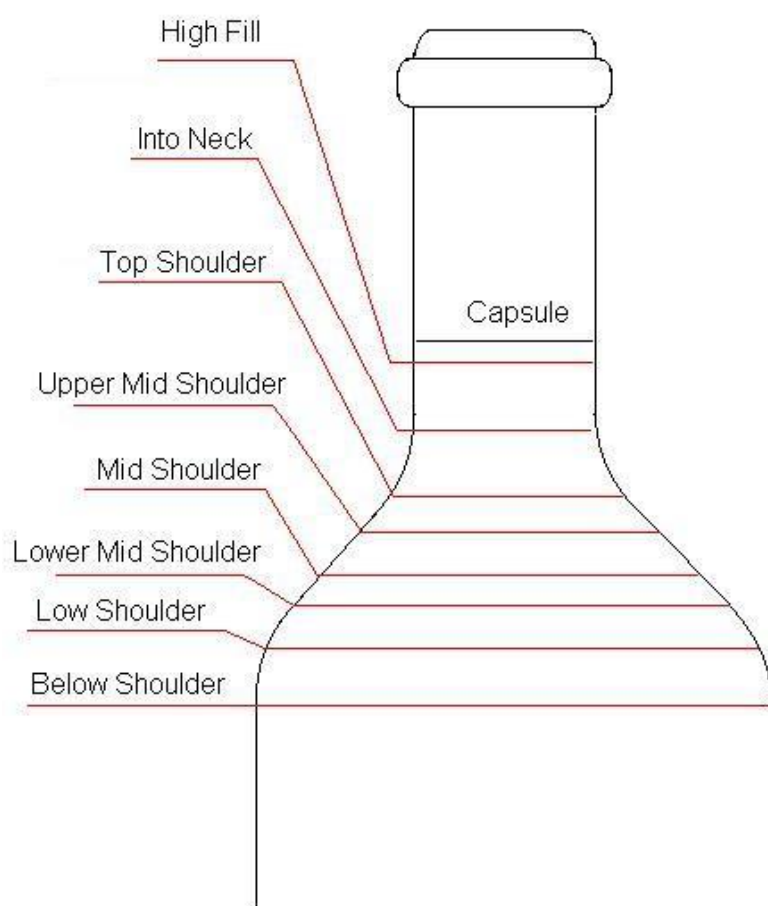
Fill Levels & Condition

Fill level (ullage) refers to the headspace between the wine and the cork. For vintage wines, significant evaporation through the cork is natural and expected.

Bottles from professional collections with proper storage conditions—such as those from Octavian's climate-controlled cellars—show fill levels consistent with excellent preservation, serving as an important indicator of storage quality and condition.

Fill levels can be assessed through multiple methods: visual inspection, condition photography, and professional evaluation by wine specialists. **Not all lots have condition photos published; however, these can be made available to buyers as part of the sale agreement upon request.**

Storage

All wines are stored in bond at Octavian, Corsham, Wiltshire—one of the UK's premier bonded wine storage facilities. Wines held in bond have not been subject to UK Excise Duty or VAT.

UK Deliveries

- Buyers may keep wines in bond by transferring them to another UK bonded warehouse (no Duty or VAT payable).
- All UK deliveries, in-bond transfers, and storage arrangements are coordinated through Octavian, with delivery timescales confirmed after order processing.
- Alternatively, buyers may take delivery to a UK address outside of bonded storage, with applicable Excise Duty and VAT becoming payable before release from bond.
- Buyers can choose to store wines at Octavian and transfer stock to their own account; Octavian operates a secure process to manage accounts and compliance.

International Shipping

Octavian does not arrange shipments outside the UK. International buyers must engage their own freight forwarder or international haulier to collect wines. A list of recommended hauliers is available upon request. Wines exported from the UK are not subject to UK Excise Duty or VAT.

Important: Import duties, taxes, and regulations in the destination country are the buyer's responsibility and vary by jurisdiction.
